

Protecting your private information is our priority. This Statement of Privacy applies to <a href="https://www.twintiersdrugtesting.com">https://www.twintiersdrugtesting.com</a> and Twin Tiers Drug Testing LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Twin Tiers Drug Testing LLC include <a href="https://www.twintiersdrugtesting.com">https://www.twintiersdrugtesting.com</a> and TTDT. The TTDT website is an ecommerce site supplying drug & alcohol testing, and DNA testing, sales, service, consulting, training, and compliance, and consulting and compliance services pertaining to the USDOT CFR Title 49. By using the TTDT website, you consent to the data practices described in this statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, TTDT may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase TTDT's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

## **Use of your Personal Information**

### **Sharing Information with Third Parties**

TTDT does not sell, rent or lease its customer lists to third parties. TTDT may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. # **Tracking User Behavior**

TTDT may keep track of the websites and pages our users visit within TTDT, in order to determine what TTDT services are the most popular. ## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by TTDT. #### **Use of Cookies**
